### TS71, TS72V & TS72VBC OVERHEAD DOOR CLOSERS

- 1. The Dorma UK Limited TS71, TS72V and TS72VBC are a range of adjustable power surface mounted overhead door closers. This approval applies to the named models but excludes any mechanical hold open variants. This approval only applies to door leaf mounted closers. It relates to their use with the following door assemblies:
- 2. This certification is designed to demonstrate compliance of the product or system specifically with Approved Document B (England and Wales), Section 2 of the Technical Standards (Scotland), Technical Booklet E (N. Ireland). If compliance is required to other regulatory or guidance documents there may be additional considerations or conflict to be taken into account.

Latched and unlatched, intumescent sealed door assemblies consisting of timber faced and edged leaves with timber, cellulosic or mineral cores in timber frames having fire resistances up to 120 minutes (Code ITT).

Latched and unlatched door assemblies (intumescent sealed or nonintumescent sealed) consisting of uninsulated or insulated metal door assemblies in metal frames, having a fire resistance of up to 240 minutes (IMM and MM).

Latched and unlatched, intumescent sealed door assemblies consisting of timber faced and edged leaves with timber, cellulosic or mineral cores in steel frames having a fire resistance up to 120 minutes (Code ITM).

- 3. The closers are approved on the basis of:
  - i) Initial type testing to EN1154 and BS EN 1634-1
  - iii) An appraisal against TS34
  - iii) Certification of quality management system to ISO 9001: 2008.
  - iv) Inspection and surveillance of factory production control
  - v) Ongoing audit testing in accordance with EN 1154 requirements
- 4. This approval is applicable only to the specified closers used with door assemblies of proven fire resistance (as defined in BS476: Part 22: 1987 or BS EN 1634-1) having power ratings appropriate to the leaf sizes subject to a minimum size 3 (as specified in BS EN 1154).
- 5. The approval relates to on going production. Product and/or its immediate packaging is identified with the manufacturer's name, the product name or number, the CERTIFIRE name or name and mark, together with the CERTIFIRE certificate number and application where appropriate.
